SuperDestroyer 1776-2001

SuperDestroyer looks at iconoclasm from its core tendencies - the primal urge to destroy. Confronting proposals such as Giuliani's establishment of a "Decency Standards Commission," in light of several controversial exhibitions at the Brooklyn Museum of Art, **SuperDestroyer** considers the legitimacy of applying standards to works of art. Namely, what if there were an acceptable "checklist of good taste" established, but in a thoroughly democratic manner?

Revisionist art history espouses that boundaries separating High and Low Art no longer exist. This may turn out to be a sophist's conclusion. One may consider the potential fallacy by looking at a comparative study of professions. For example, medical students go to med school to become doctors. Likewise, art students go to art school to become artists. They become "experts" in their chosen field. Yet the latter, in an effort to marginalize (an extreme form of elitism) themselves from the etiquette of mainstream professions by claiming no distinguishing characteristics between High and Low art, subsequently blur recognition of Good or Bad art - is there no difference between Good and Bad medicine either? This is not to insist that outlining what is good or bad or high or low is an easy task. On the contrary, it is a tremendous task. A task, nonetheless, that should be considered on a case to case basis. The other vantage, a levelling, and ultimately Western viewpoint, is an equivocal position easily debunked when looking at the constitution of museum and gallery inventories. The disparity between action and theory is apparent - Harley Davidson and Giorgio Armani notwithstanding. It is safe to presume that both these reputable "artists" will find no second run at next year's Documenta despite the Guggenheim high profiling.

With that said, **SuperDestroyer** proposes to ignite a democratic bonfire of the vanities by placing an industrial woodchipper (**SuperDestroyer**) at the center of an exhibition space. Those who make or own work which they deem "bad art" are encouraged to bring their works into the gallery and submit it for annihilation and re-shaping. Once thrown into the woodchipper, each artwork will be torn asunder and remediated into usable mulch which will eventually cover the exhibition space's floor. Metaphorically this may be seen as the erasure of the (elitist) white space. But this is not the intention, which is simply of a practical (Low?) nature - dispose bad art and transform it into something useful and visually palatable. Modern day fascists would shut down entire public institutions over a single "degenerate" work. **SuperDestroyer** extends this priveledge of judgement to all individuals, confronting them to discriminate and establish their own standards of worthy or worthless art. If the mayor wants to censure Renee Cox's photograph, then let him remove it by purchase and then introduce it to **SuperDestroyer**. Making art is the act of expressing the individual. Destroying it should be the same, but only through consensual means beyond the boundaries of fascism.

Submissions for disposal each day - paintings, sculptures, etc - will be hung on the walls and/or placed on pedestals, that is to say, exhibited properly, the following day for the general public to view and individually evaluate the quality of prior to the inevitable. The former day's works will be introduced to **SuperDestroyer**. This routine will continue each day for the duration of the exhibition.

At the exhibition's conclusion, the heap of re-constituted art will be collected into small plastic bags and distributed as landscaping material - albeit of an uncommon composition, depending on the discarded items. If blurring High and Low innocuates the notion of the rarefied object, then **SuperDestroyer** ups the ante by literally obliterating the object - rarefied or not. As with the "people's choice" works of Komar and Melamid, **SuperDestroyer** allows the citizens (individual, mayoral, or otherwise) to judge what is preferred, bad, good, infernal, or indecent.

In a society obsessed with accumulation and the preservation of objects and outliving death, **SuperDestroyer** says "Let loose the Kracken!"
