



- 3.31-4.01.01 I met C. once more, this time at a party in Williamsburg, Hope Street, a second story loft, fixed up here and there. The water and electrical pipes resembled a roadmap hovered from the ceiling. Every wall was spraypainted white, like my own studio. Various abssesses in the sheetrock dug out by overzealous artists and accordion foil pipes protruded from above. Two mirror balls suspended in the middle room accommodated dancing. Every now and then some giddy woman would twirl the ball - the ceiling was standard height - staring starry-eyed in bemusement at its play on reflection and shadow as the glass squares bounced off red and yellow rays from bulbs of like color. Striking coy poses like a Botticelli Hermes, their lip gloss would beam back at you like the sudden glimmer of bright white fresh teeth in a toothpaste commercial. There was something somewhat a little Dirk Diggler about the ambience. It wasn't necessarily disco, it was the Cars, actually. Maybe it was something in between The Last Days of Disco and Pierre et Gilles. We were hoping for something with a little more soul, regardless. Or Beastie Boys, definitely James. The twinkle in the eye accompanied the giddy teeth and suave fingers. Two people on the floor of note. The first was a small woman, dressed in snug blue jeans and a swirls printed polyester long sleeve t-shirt. She was the type of dancer who designated and expanded at will her own floor space. She started in the center of the room and worked

her way out to a corner, the corner where her boyfriend appendage stood, one shoulder leaning against the wall, one leg crossing the other, a forced closed-lips smile, eyes hinged to her every move. He didn't want to dance but she could and he couldn't so she did and he didn't and there she went, girating all over the place like Brooklyn direly needed rain, her stare reciprocally transfixed on mister wallflower. A palm slap on the rear here, a finger brush on the knee there, a quick pirouette, a stomp tap forward of the boot, hair whipping, and neck snapping back in his direction and next moment she was in blushed proximity to his stillness. The only missing ingredient was a neigh. This was the kind of mental lapdance exhibitionism we were lacking in graduate school. She created an audience, he wanted no part of this diversion but tried playing it cool anyway. Her facial expression remained stoic, her brazen eyes did all the talking, her body moved to something everyone else surely was not in rhythm with. Unfortunately, the other half exorcised her in the end with his pout-about. She stopped, walk over, his smile widened, she tugged at his shirt in aweshuckness, he acted like it was all all right, they'll leave immediately and roll in the hey. Billieburg High revisited. The second was some Barenaked Ladies tryout who missed out on an audition for the making of the band. Blonded moussed up and back hair, dark brown BH glasses whose better half was a Latino woman who shuffled about, all the while with a dangling cigarette in hand. On a normal basis, the pair would have merited modest attention. Except that periodically, on this occasion, the Barenaked Ladies Man felt some primal need to yelp like a Mohican in my ear from whatever interior prompt, the sound was akin to a battle cry gone the way of a misthroated Zena. His girlfriend was there though, to shake her head at me in post-representation of dispproving approval of the fellow's every eeee-eee-eee. Oh well, at least the pejorative music somewhat drowned it out. This music, which could be described as a hybrid of sorts, was sporadic entertainment at best in its intermittent play of lackluster yet bearable formless song mixing. There was little recognition. The deejay equipment tucked behind an open door to the adjacent room. The deejay was nowhere to be seen. K. and E. and L. and I (collectively we were K-TEL) decided it was time for a little sound check and change. So we nudged through the throng of Brooklyn's most courteous party goers and made our way out, slipping past numerous metal makeshift bookshelves in the corridor leading to the front door. There were actually people propped against the wall with books in their hands. It must have been some library! These studious bibliophiles were on cigarette break. Temporary outcasts. Those extra fidgety individuals whose digits anxiously preoccupy themselves while the nicotine made its rounds. Or maybe they were just plain decent bookworms like the rest of us. K-TEL left the building, walked down and across Hope Street to Roebling and then around the bend to the corner of Grand. Welcome to Stingers. The smokebowl effect could be seen through the one barfront window before we even entered, which did not appeal to the olfactory senses or clothes at that evening moment. I followed the three in. It was a small neighborhood bar, a mix of mostly Hispanics and the rest of us. These usual patrons lounged and conversed above the din of hip hop. We walked pass the stools, parading by to the measuring up and down scopes of the barflies. At the end of the bar was a slightly raised platform which constituted the dance floor. About ten people could fit in and motion about

in close quarters. Our small group planted ourselves in the middle somehow. This was not a change for the better. Too much smoke in the air. Cramped. It felt like too much work, too much fighting for space. I opted for recourse to the loft on Hope Street, wanting for comfortable elbow room, and a little more oxygen. I backtracked outside. The night was nice and opportune for a walk. I did without a jacket, without looking at cars drive by or groups of galavanters looking for a way home. There were no indications of mean streets, retracing the route required little effort. The metal, narrow, wall-hugging steps between buildings leading up to the loft seemed more like an emergency fire escape route than any sort of formal entrance. Going back into the smoky atmosphere, past the previous readers, into the makeshift nightclub. Mirror balls twirling. Getting deliberately lost in the mix of full throttled revelers, I caught up with C. again in a clearing on the floor. And we danced.

Potato-stamped with red ink "tn" on first page. Reading this book makes you determined to look at a De Chirico painting... The sky description: a sallow yellow dissolving northwards into a nauseous blue green, very subtle and sickly. Oceanic. A gray building in the middle of an almost deserted city - the middleground - with three archways, and three windows directly above the same entryways lacking in perspective. Night-colored beyond these portals aside from a single visible fourth window through the far left arch. There were always trains that sped through such cities, like clockwork along the linear, flat horizon stripe. The stops were intentionally clinical. Dropped off at a school cafeteria. Its fold-up picnic tables and cinder blocked walls, white with black speckles tiled floor. The double-door entrance which let a certain amount of daylight in. The Saturday morning light one encounters when taking the SAT. There was one other gasp of light, way up high on the eastern wall, a plain square opening through which pigeons sometimes flew and eschewed, where the occasional dead leaf came spiriting through with the aid of a mild sirocco. Faces and groups of people that you see over and over again, like a band of unwanted guardian apparitions that accompanies you through the numerous courses of life, tracing your trajectory with you. The ones who got off at the same stops. And theirs is the nature of your education. The primary school ratpack consisting of names mostly forgotten - Jack, Angela, Tony, Alicia, Tammy, Rebecca, James, Monte, Tuyen, John. But whose faces remain indelible etchings imprinted in your memory, like the blond-haired girl (Karen, was it?) who lived down the block, on the same side of the road three houses apart, who went and stood behind the screen door of her porch while the three of us were all making friendship bracelets out of multi-colored beads (first lesson in color theory) and strings, where there came a gangly looking kid, punkish,

eccentric, older. Were we reared to be so homogenous even at that age? Your course begins with a palette of fighters, intergalactic battles, photorealism (always this genre), feuds between light and darkness, good and evil, fashion, and technique. A classicism. Porticoes with Romanesque arches buttressed on spare, square columns. There stands in isolation a statue of a recumbent woman in the courtyard (piazza), draped in thick cloth betraying the stone or marble construction. Her left arm supported an indescript and pensive countenance, the other arm slung above her head, framing it like a gable. There stood in mute conversation two professors (dressed in coats and hats) in cordial proximity in the distance, as the train silently rolled through, visible just beyond the exterior brick wall to the bastion of a city. A single cloud of smoke puffed straight upwards from its coal-driven engines. At this particular exact moment it was flanked in the middle and foreground by the arching porticoes, perfectly framed. The walls, people, statue, and buildings colored in secondary light all cast elongated shadows angled in unison, signaling the languor of the barren afternoon. But it would stop at similar towns, the seemingly nondifference that somewhat irritates a person, like traveling in circles around Meadowlake Park where I use to play as a child in the miniaturized train that revealed liitle in its grand tour of the park except what one terms nature and the leisure activities people participate in on the fatigued weekends. And the pedal-boats where brothers flexed their biceps at passerbys and inverted frisbees scooped water. The only monument there worth mentioning was a gigantic aluminum slide, about fifty feet high and inclined to 30 degrees. You would have to walk up all these steps on the opposite side of the hill where it rested and queue up behind other anxious kids. The ride was a speedy descent that ended with a propellant boy or girl flung into a momentum-stopping sand pit. And even this slide was not visible on Meadowlake's scenic route. But this had nothing to do with the picturesque. This had more in common with the ever more mundane, like the tan ochre color of the ground in the courtyard where that statue stood quiet and comntemplative. I don't recall the number of stops or where I got off on this train. What is recalled is the attraction of the individuals, the bond of the rail passengers. And the disquietude of any separation from them. How many or which ones, that is not certain. Two people, twenty, who knows? A red-locked girl, a black-haired boy. At the very least. We ate in that same cafeteria together. The words which were exchanged is another uncertainty. Perhaps there was just the movement of lips, nothing spoken. Unless one read lips. And eyes and gestures and signals for departing and embarking. It was a single freeze-frame moment at lunch inside the cafeteria with the eastern window way at the top near the ceiling's edge. What was spoken? The sound of the horn (bell? whistle? alarm?) notified us of the train's imminent departure in five minutes. There was an express and a local, like the New York City subways. We were on our way again. Moving. Locomotion. We all raced outside along the platform of the railstation, trying to catch the train. The length of the platform seemed endless. We were gasping with shortness of breath from the running. Some made it. Some didn't. The schedule board inside the terminal identified subsequent lines. The one that just left was a local. Perhaps we can catch up to them on the next express, we thought. So the next one it was. I sat face to face across from a boy and a girl whom I recognized from the cafeteria. But we did not speak. The expressions on our

faces revealed what must have been the same anticipation and anxiety associated with journeying on a drift. The anticipation of destination. The anxiety of wondering whether this latter train will catch the previous. It must. Or else. Until that intersection, we occasionally glance at one another and stare out the windows at red bricked walls and panoplied fortresses in the landscape. Brought back to the original state of silence. The climate is ripe for this uneasy serenity. It was initially the sound of that horn that broke this familiar silence, that separated and differentiated. The greatest metaphysical tragedy is such a form of separation, a soundproof unknowingness of all individuals. How can we come to know ourselves if we fail to know all others? How to narrow the six degrees of separation?




